Colombia


Senator Juan Manuel Galan



Senator Galan is a member of Colombia's Liberal Party in his second term in the Colombian Senate. He has been Vice Minister for Youth Initiatives, Ambassador to London and, since 2006, a Senator in the Colombian Congress. Sen. Galan has promoted initiatives against corruption, abuse of human rights, and reform of the health system. He earned two MA degrees in Political Science and International Relations at France's Institute

of Political Studies and at Georgetown University in Washington, DC.

Senator Juan Mario Laserna



Senator Laserna is a member of Colombia's Conservative Party. He was part of President Gaviria's economic team and later Gaviria's Chief of Staff at the Organization of American States. Senator Laserna was named by President Uribe as Director for Capital Markets at the Inter-American Development Bank and later was named Director of Colombia's Central Bank. In 2010, he was elected to the Colombian Senate. He is an economist from Yale University and has an MBA from Stanford University.





Paraguay

Senator Hugo Estigarribia



Senator Estigarribia is a member of Paraguay's Colorado Party. He worked for the national government and as a judge between 1985 and 1990; was a member of Paraguay's Constitutional Convention (1991), Vice Minister for Youth (1996-98), and Advisor on political affairs for the Vice President of the Republic (2003/07). He has worked as consultant for many international organizations and is widely published. Senator Estigarribia is a lawyer of Paraguay's National University and holds a MA in Political Science from the same university. He also has a post-graduate degree in Public Administration from Shenandoah University in Virginia

and an LLM in Law and Legal Studies from American University in Washington, DC.

Governor Carlos Alberto Amarilla



He is the former Governor of the Department (State) of Central in Paraguay, the largest and most populous Department of the country. An accountant by profession, Mr. Amarilla has a long and distinguished career in both the private and public sector. A member of the Liberal Party, he is now a Senate candidate in the upcoming national elections.

Panama

Director Rodolfo Caballero



Mr. Caballero is the National Director for Citizen Participation and Government Innovations, Government of Panama. He has designed and implemented the entire country's 311 Citizens' concern call center. In addition, he has worked as a business consultant for many international, national, and regional organizations in the areas of strategic planning, organization, and institutional strengthening.
